5. Communicate with employees, suppliers, customers, and regulatory agencies, regarding our environmental activities, where necessary and appropriate.
6. Incorporate environmental considerations into relevant business decisions.

This policy will be achieved by:

- Job specific annual training for employees.
- Company-wide communication to staff and other interested parties.
- The use of less hazardous materials, where appropriate.
- Identifying areas of improvement during annual review, and reporting to senior management.
